The cafe is also environmentally conscious. Their use of ecological materials such as paper cup lids and biodegradable straws invites you to be an environmentally friendly traveler.

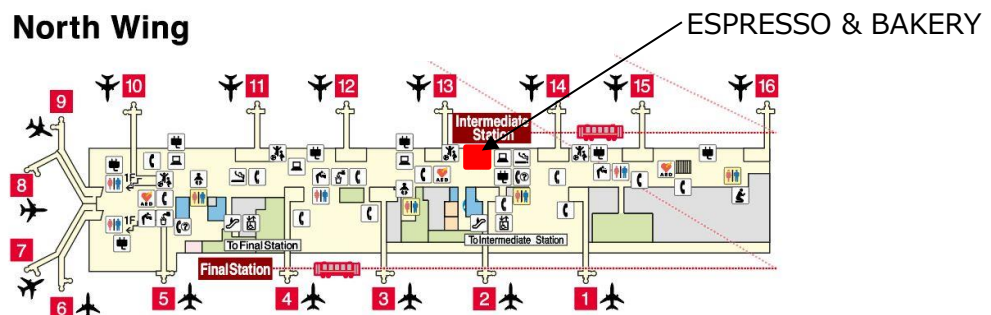
Kansai Airports will continue to explore every option of store development at its airports to bring fun and excitement to your travel experience.
