

# Easter Jet launches seasonal flights between KIX and Cheongju

- Only airport in Japan to fly to Cheongju, South Korea

Kansai Airports is excited to announce that Easter Jet will launch three weekly seasonal flights from Kansai International Airport (KIX) to Cheongju in South Korea on Thursday, May 3, 2018.

Easter Jet is a South Korea-based low-cost carrier, currently operating 21 flights weekly from KIX to Seoul (Incheon) and Busan.

As it stands, there are no regular flights between Japan and Cheongju, so this will be the only regular service connecting the country with Cheongju. With the newly launched service, a total of 24 weekly flights will be operated between KIX and three destinations in Korea, including Cheongju.

The new route will serve the strong inbound demand from Korea as well as the outbound travel demand among Japanese, which is expected to increase during summer.

Kansai Airports is committed to expanding its network together with airlines including Asian low-cost carriers to provide convenient, comfortable and enjoyable travel experiences for airport guests.
