

Jeju Air to move to Terminal 2 of Kansai International Airport from Thursday, November 1, 2018

Kansai Airports hereby announce that Jeju Air (7C) will be transferred to Terminal 2 (International), LCC terminal, of Kansai International Airport starting from Thursday, November 1, 2018.

Jeju Air, Korean LCC, currently operates 66 flights per week between Seoul (Incheon/Gimpo), Busan and Muan. The company is also planning to open Cheongju and Guam route starting from Saturday, July 21.

Since its opening last January, Terminal 2 (International) has been used by Peach Aviation and Chinese LCC Spring Airlines, and Jeju Air will be the third airline company to operate in the Terminal.

Kansai Airports is committed to enhancing the convenience of customers and creating comfortable and enjoyable journey.
