Domestic passenger service facility charge (PSFC) to be introduced at KIX Terminal 1 and ITAMI

Kansai Airports announced that a passenger service facility charge (PSFC) will be introduced for domestic flights to and from Osaka International Airport (ITAMI) and Terminal 1 at Kansai International Airport (KIX) on October 28, 2018.

Facility charges, currently borne by airlines, will be paid by passengers to airlines when they purchase a plane ticket.

Collected charges will be used to further improve airport facilities and services to deliver a more comfortable and convenient experience to passengers. A recent example of such enhancement is the renovation of ITAMI including arrival and departure lobbies, where its central area reopened ahead of the other areas this April.

Kansai Airports is committed to exceeding customer expectations by offering a new travel experience and a more friendly environment to all of its customers.


