Kansai Airports Group is introducing new payment options in series – WeChat Pay, UnionPay QR, UnionPay mobile QuickPass, and JCB Contactless – as an effort to promote cashless transactions at its three airports, Kansai International Airport (KIX), Osaka International Airport (ITAMI) and Kobe Airport (KOBE).

In recent years, KIX has been bustling with passengers from all around the world and there have been growing needs for a wide range of payment methods. Crowded cash registers have also been a problem at the three airports that serve, when combined, nearly 50 million passengers a year. To address these situations and provide airport guests with a stress-free shopping environment, Kansai Airports Group has been actively pushing forward cashless payment services.

Kansai Airports Group will introduce more payment services including WeChat Pay to further enhance customer convenience, adding up to a total of 20 payment options available at the three airports. Along with that, it will unify payment terminals across these airports, making payment processes more user-friendly. This is expected to help simplify shop operations, ease congestion at cash registers and meet diversifying payment needs. The airports are further planning to implement cashless transaction promotions such as campaigns jointly organized with payment service brands.

Kansai Airports Group is committed to actively introducing state-of-the-art technology and services to create a comfortable and convenient airport environment for all airport guests.
