



## Passenger service charges to be revised at Kansai International Airport

Kansai Airports today announced that the passenger service facility charge (PSFC) and passenger security service charge (PSSC) at Kansai International Airport (KIX) will be raised beginning October 1, 2019 in line with the consumption tax increase.

The PSFC is currently charged to passengers using KIX and Osaka International Airport (ITAMI). The collected fees are used for the improvement of airport services and facilities, including departure and arrival lobbies, to enhance the convenience and comfort of passengers.

International passengers departing KIX are also charged with the PSSC for safety and security services such as the maintenance and management of screening equipment and terminal buildings.

By improving the airport environment, Kansai Airports is committed to meeting customers' expectations and providing them with an exceptional travel experience.

### International flights at KIX Terminal 1

The Child fares are applied to those using a discounted ticket for children. Infants under two years of age not occupying a seat are free of charge.

### Domestic flights at KIX Terminal 1

The Child fares are applied to those under 12 years of age. Infants under three years of age not occupying a seat are free of charge.

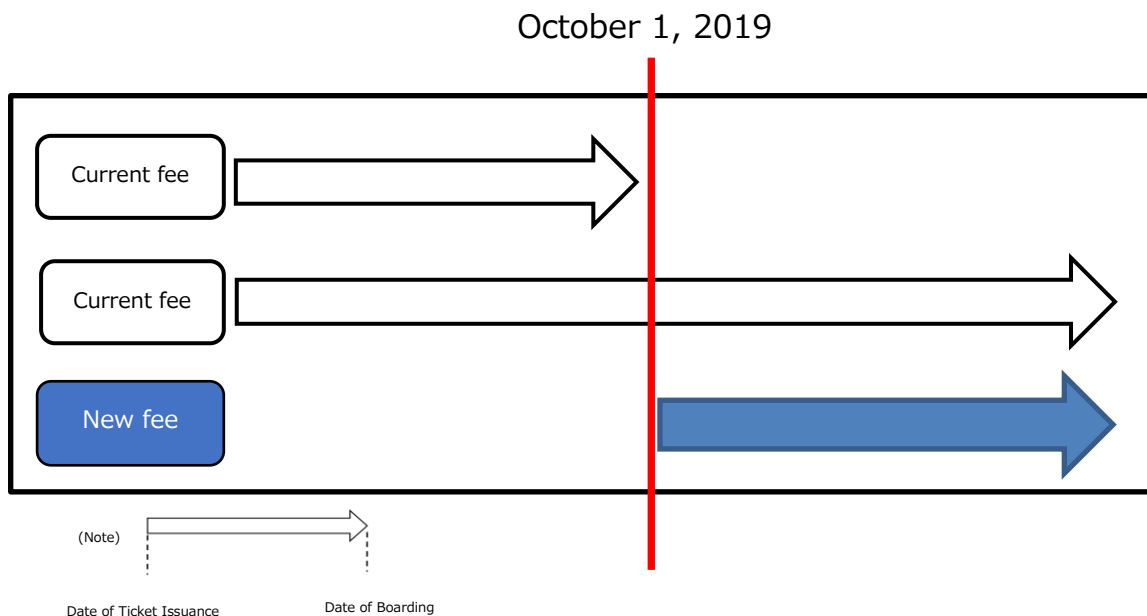
### KIX Terminal 2

There is no Child fare. Note that international passengers under two years of age without a seat and domestic passengers under three years of age without a seat are free of charge.

<sup>2</sup>Connecting passengers:

Passengers who arrive at KIX for a transit stop and depart KIX within 24 hours of arrival using a single ticket, regardless of whether they leave the airport or not during the transfer period.
