



Hainan Airlines to launch KIX-Beijing and KIX-Lianyungang-Lanzhou services

Kansai Airports is pleased to announce that Hainan Airlines (HU) will offer new service from Kansai International Airport (KIX) to Beijing, starting October 29, 2019. The Chinese airline will also launch a route from KIX to Lanzhou via Lianyungang, a brand-new destination for KIX, on November 25 this year.

Hainan Airlines, which resumed flights to KIX this February, has been awarded the Skytrax World 5-Star Airline rating for the ninth consecutive year.

With the addition of new services, the airline will be offering a total of five destinations in China from KIX, including Shenzhen, Haikou and Xi'an. The upcoming flights are expected to further boost demand for air travel between the two countries.
